Who should apply?

Small or large, CFA have a membership category to suit most companies who can demonstrate they are actively and credibly involved in installing flooring material in a contract environment. The two categories available for contractor membership are **Contractor** and **Associate Contractor**.

Basic Membership Criteria	Contractor	Associate Contractor
Number of Years Trading	The company generally must have been trading for a minimum of three years.	The company generally must have been trading for a minimum of one year.
Accounts	The company generally must have three years trading accounts (for Plc/Ltd/LLP filed with Companies House).	The company generally must have one year's trading accounts accompanying application.
Solvency	The company must not, in the reasonable view of CFA, be or likely to become financially insolvent (CFA credit checks all applicants).	
References	CFA must be able to obtain positive trade and client references.	
Activity	The majority of work and focus must be within the contract flooring market.	Applicants must be able to demonstrate significant and credible (but not necessarily exclusive) activity within the contract flooring market.
Premises	Must be operating from suitable business premises. This should include a permanent administration office and if applicable, suitable warehouse / storage facility.	Must be operating from a registered business address.
Application Fee	The CFA charges an application fee of £150 plus VAT, which is non-refundable.	

Both categories enjoy equal benefits and support.
